# **President's Report**

# Referee Coordinator/Referee-in-Chief

- Dwight absent
- Keith not a lot of work up until now but it's been a struggle to get enough officials for tournaments. Have had to rely on officials from the Pass for two tournaments already; Novice and Bantam. We have had a lot of games in Sparwood and we only really have two officials in Sparwood.
- A suggestion was made that a course that isn't so intensive for officials for Pre-Novice, Novice and Atoms to encourage more officials.

#### **Coach Coordinator**

- All coaches and assistant coaches are now certified and those that attended the courses in the last year just need to complete the post task.
- Out of 16 coaches registered to coach, only six attended the in-class portion of the coach stream in Cranbrook.
   Those that didn't take the course were then taken off the roster as an assistant coach and added as a volunteer so that the coaches were not left shorthanded during practices.
- Jera discussed with BC Hockey what the role of a volunteer is and what they are qualified to do. The exact quote that was given to Jera was, "A volunteer is an extra set of hands and skates on the ice, they have no coaching authority what so ever and are not allowed to be on the bench during any games". Jera reiterated the quote when notifying the uncertified coaches of their role change. One coach, who is now uncertified, was upset and felt the wording was disrespectful since he has committed so much to our association in the past. Jera was told that direct communication from her was not acceptable anymore and must go through the Manager in the future. It was decided that communication about coach, bench staff certifications, etc. will be sent to the Head Coach of each team and not to individual coaches. It will be the responsibility of the Head Coaches to ensure that their bench staff is up to date on all certifications via the Coach Coordinator.

- East Kootenay Community Credit Union is sponsoring Zamboni races in Cranbrook on January 24<sup>th</sup>.
